LEGISLATIVE NEWS

RECOMMENDED CHANGES TO CONSTITUTION AND BYLAWS

These are recommended changes to the JJAM constitution and bylaws. These will be voted on at the September 2010 conference.

Changes to Constitution

Article II – Membership

Section 1 – Membership is limited to the personnel of various Juvenile Courts within Michigan.

Change: Membership is limited to the personnel of various Juvenile Courts and child care agencies within Michigan.

Section 5 – Associate membership is open to persons such as:

- Department of Social Services Workers
- Foster parents
- School personnel
- Police officers
- Private child care agency personnel

And/or any person actively engaged in enhancing a child or family welfare program who pays annual dues. The Associate member shall enjoy every privilege of this Association, except the right or hold office.

Change: Associate membership is open to any person or organization actively engaged in enhancing a child or family welfare program who pays annual dues. The Associate member shall enjoy every privilege of this Association, except the right to hold board positions.

Section 6 – Associate child-caring agency membership is open to non-court personnel representing a child care agency who recruit or derive benefit from the Juvenile Justice Association of Michigan membership for their own agency.

Change: Delete

Section 7 is now 6 and 8 is now 7

Article III – Government

Section 1 – The State Board of Directors of the Juvenile Justice Association of Michigan shall be comprised of the Directors from each of the nine regions, the President, and immediate Past President. Within the State Board of Directors there will be chosen a Vice-President, a Secretary, and a Treasurer.

Change: The State Board of Directors of the Juvenile Justice Association of Michigan shall be comprised of the Directors and alternates from each of the ten regions, the President, and immediate Past President. Within the State Board of Directors there will be chosen a Vice-President, a Secretary, and a Treasurer.

Section 2 – The president shall be elected by vote of the membership at the annual conference. The president shall not serve more than two consecutive terms in that office. The president shall take office immediately at the close of the annual conference.

Change: The president shall be elected by vote of membership at the annual conference. The president shall take office immediately following the vote at the annual conference. There are no term limits.

Section 5 – The State Board of Directors may employ such assistants or committees as deemed necessary.

Change: The State Board of Directors may assign alternates and committees as deemed necessary.

Article IV – Regions

Section 2 – There shall be nine regions within the state.

Change: There shall be ten regions within the state.

Changes to By Laws

Article III – State Board of Directors

Section 2 – The State Board of Directors shall elect from within that Board, a Vice-President, Secretary and Treasurer.

Change: The State Board of Directors shall elect from within that Board, a Vice-President, Secretary

and Treasurer who have served at least 2 years as either a director or alternate director for the Board

Article V – Regions

Section 1

Region 1 – Alger, Baraga, Chippewa, Delta, Dickinson, Gogebic, Houghton, Iron, Keweenaw, Luce, Mackinaw, Marquette, Menominee, Ontonagon, Schoolcraft

Change: Alger, Chippewa, Delta, Luce, Mackinac, Menominee, Schoolcraft

Change: Add Region 10 – Baraga, Dickinson, Gogebic, Houghton, Iron, Keweenaw, Marquette, Ontonagon

Section 2 – Organization

b. Each region may have a Secretary-Treasurer.

Change: Each region may elect an alternate director.

Article VI – Membership Dues

Section 2 – The dues of Associate Members shall be \$15.00 per year.

Change: Delete

Section 3 is now 2, 4 is now 3, 5 is now 4

REGIONAL NEWS

REGION 1 NEWS

The Sault Tribal court has been awarded a U.S. Department of Justice grant in the amount of \$448,834 for improvements to the tribal juvenile justice system. The grant is the largest ever received by tribal court. The grant is a renewable four-year grant with the first year reserved for planning, followed with three years of implementation. Court Administrator and Magistrate Judge Kellie LaVictor, and Juvenile Probation Office Jennifer Blair say the grant will be used to purchase much needed case management software at a cost of \$142,000, fund a teen court program and provide enhanced services through the STEP (Sault Tribe Enhanced Probation) program for youth in jeopardy of being removed from their home due to escalating violent behavior and delinquency issues after all other options are exhausted. Also, tribal teen court program was developed in 2005 but was never fully implemented. The grant will allow that program to become operations by the start of the 2010 school year, making it the first teen court in the Upper Peninsula. Youth volunteers from the tribe's various programs and tribal youth from area schools will serve in every aspect of the court; including bailiff, prosecution and defense attorneys and court reporter. Teen court addresses a broad range of less serious offenses in a culturally appropriate way. The program will help status and non-violent first time offenders learn that by making better choices they can make a positive impact on their tribal community. If a youth comes through tribal court with a status offense such as truancy, smoking or minor in possession and they are a first time offender, they can opt to go through teen court. Everyone in teen court, with the exception of the judge, is a teen who has been trained by his or her counterpart to take on a particular role. The grant will allow the court to contract with an attorney in order to train the youth and be there during court, and will provide additional funds for transportation to and from court for participants.

PROGRAM HIGHLIGHT

GENESEEE COUNTY JMHC PROGRAM

The JMHC program was started in April 2009 with 4 kids. We now have 12 kids (5 boys and 7 girls) and will continue to grow. Our first "graduation" will be in January 2010.

The minimum length of the program is 9 months. The kids report to Judge Jennie Barkey on a weekly basis (Mondays at 3:30pm) and we go over the successes and failures of the week. We put emphasis on whether the client participated in therapy and are taking their prescribed medications. We make sure the families follow through with all appointments. I check in throughout the week with each family and I do school visits with all the kids.

The program is done in conjunction with CMH so all the therapists are there each week and are able to provide their input. It is sort of the "wraparound" approach.

We use a variety of sanctions and rewards. Some sanctions include: community service; more than one court date per week; tether; writing assignments; loss of privileges; secure detention. Some rewards include: fewer court appearances; gaining back privileges; applause.

It is still a work in progress but we are learning.

Here are some criteria for this program.

Mental Health Court Clinical Criteria

The youth would be required to have an Axis I diagnosis (i.e. mood disorder, depressive disorder, psychotic disorder, PTSD, severe ADHD, persistent adjustment disorder, anxiety disorder) causing a significant impairment in daily functioning, school performance, social relationships, and ability to comply with standard rules of probation.

Primary Axis II diagnosis or substance abuse diagnosis without co-occurring MI diagnosis where

MI is primary would exclude involvement in MH court.

Prior attempt(s) at treatment has been unsuccessful due to:

- Lack of proper type, duration, or intensity of treatment
- Lack of adequate support for treatment engagement
- Non-compliance with treatment regimen by youth or family

Or

Indications or worsening symptoms and decline in functioning (if treatment has been successful and is ongoing youth may not be a need to be brought into MH court)

Youth and parent/guardian must be “competent” and able to understand the Mental Health court process and expectations.

Family dynamics would need to be assessed in order to determine whether any existing issues would interfere with the goals of the youth and court. These issues would need to be addressed by the court to improve probability of a successful outcome.

MID-WINTER CONFERENCE/ SEMINAR

THURSDAY, MARCH 25, 2010

LIES THAT BIND® “MARCHING TO THE BEAT OF THE LOUDEST DRUM – LIFE IN THE HOOD”

Anneshia Freeman, MBA, CAC-M

This training will provide service providers with an insider’s perspective of what is going on with youth raised in the “hood” and various other subcultures. Many organizations provide cultural competency trainings, which are good and important, but if the population one serves is born and raised in a subculture, then one needs information about that environment.

The objectives for the Lies That Bind® “Marching to the Beat of the Loudest Drum – Life in the Hood” training are as follows:

Objective I – Participants will be able to identify how the unconscious self-concept is formed and the role of the unconscious self-concept in the decision making process of youth and adults

- The foundation of experience
- Developmental tasks
- Resolution of the psychosocial crisis

Objective II – Participants will be able to identify “Hood” belief systems

- Origins of those beliefs
- Conscious versus unconscious “hood” beliefs
- How “hood” beliefs are used by the illegal opportunity structure for profit
- How youth are solicited into the illegal opportunity structure based on Maslov’s Hierarchy of Needs

- The dynamics of the “Game” aka “The Trap”

Objective III – Participants will be able to identify the role of the media in structuring the decision making process of youth

Objective IV – Participants will be able to identify the difference between the dominant culture belief system and subculture belief systems

Objective V – Participants will be able to identify the unconscious beliefs of some service providers that negatively impact the population they serve (“hood” residents)

Objective VI – Participants will be able to identify four strategies for reprogramming negative unconscious belief systems and four resocialization techniques.

Annessia Freeman is the creator and Director of a copy-written, trademarked, cognitive restructuring and resocialization program entitled *The Lies That Bind – The Legacy of the Locks®*. The program is based on the work of several experts in the fields of neuroscience and psychology as well as the results of a 15-year participant observation, exploratory ethnographic research project on several inner-city subcultures. Currently Annessia is employed at Arbor Circle where she has trained nine MSW therapists in her program methodology. The methodology is being piloted within the Mission Inn program which assists women with children under the age of five in stopping the generational cycles of drug addiction and poverty in their family. *The Lies That Bind®* is currently being utilized by 61st District Court’s Drug Court and Sobriety Court programs. Annessia is also an outreach counselor with Arbor Circle’s Street Outreach Program which services inner-city youth ages 21 and under. Annessia has developed an adolescent version of the *Lies That Bind®* Program that is in its fourth pilot targeting severely wounded, high-risk, inner-city youth. Annessia is a Certified Addiction Counselor (CAC-M) and recently completed her MBA.

FRIDAY, MARCH 26, 2010

PILLS + SKILLS = SUCCESS: UNDERSTANDING PSYCHOTROPIC MEDIATIONS IN THE JUVENILE JUSTICE SYSTEM

Mark A. Sloane, DO, FACOP, FAAP

Dr. Sloane will provide the conference attendee with basic principles of psychotropic medication as used in the juvenile justice system. His novel approach describing the brain-behavior connection in juvenile justice youth will allow the participant to better understand the use of psychotropic medication in this population, far beyond the limited scope of the DSM-IV.

Mark A. Sloan, DO has been a board-certified pediatrician for more than 26 years. He began his career in rural Southwest Michigan and has practiced in Kalamazoo for more than 19 years. Dr. Sloan has been interested in behavioral/developmental pediatrics for 24 years, and is now considered a local, regional, and statewide expert in the diagnosis and treatment of pediatric disorders of mood, behavior, learning, and attention. He has evaluated and treated more than 7,500 children with these disorders, and in 2003 opened a specialty practice (Center for Behavioral Pediatrics in Portage, MI) limited to neurobehavioral/neurodevelopmental pediatrics.

Sloane, a 1979 graduate of Michigan State University – College of Osteopathic Medicine (MSU-COM), has completed specialized (fellowship) training in adolescent behavioral medicine at Michigan State University- Kalamazoo Center for Medical Studies (MSU-KCMS). He is founding member of the SW Michigan Children’s Trauma Assessment Center (CTAC) (at Western Michigan University in Kalamazoo) transdisciplinary team and has clinical experience in the medication management of more than 700 children and adolescents exposed to traumatic stress and/or prenatal drug & alcohol.

His current research interests include the neurobiology and psychopharmacological treatment of a variety of childhood neurobehavioral disorders, including: ADHD, alertness/arousal dysfunction in

children and adolescents, the interface of neurodevelopment, mood, attention and behavior in children and adolescents, as well as neurobehavioral problems associated with child maltreatment and prenatal alcohol/drug exposure.

Dr. Sloane has co-authored numerous publications involving behavioral/ developmental pediatric topics. He has given over 600 presentations involving a variety of behavioral/developmental pediatrics topics to parents/caregivers, educators, allied health professionals, mental health professionals, legal professionals, and physicians in Michigan, Indiana, Illinois, Pennsylvania, Montana, Washington, D.C. and Canada.

LGBT YOUTH IN THE JUVENILE JUSTICE SYSTEM

Tamiko Rothhorn, MA, LMFT, RDT

This workshop will explore issues and challenges unique to lesbian, gay, bisexual and transgender (LGBT) youth, with emphasis on young people in the Juvenile Justice System. Topics covered will include the myths and stereotypes regarding LGBT youth, defining harassment and the use of non-discriminatory language, clinical issues affecting LGBT youth, and practical suggestions on how to serve LGBT youth equitably and respectfully. Practical solutions will be emphasized as well as suggestions for creating hate-free and affirming environments for youth in the legal system.

MARYLYNN MORAWA 2010 YOUTH ACHIEVEMENT AWARD NOMINATION

In 1985, the Juvenile Justice Association of Michigan established the Juvenile Justice Association Youth Achievement Award. An award will be presented to a Michigan youth who meets the criteria outlined below.

It is the intent of the Association, through this award program to (1) recognize an individual who has overcome some personal hardship, i.e., neglect, abuse, delinquency; (2) encourage civic responsibility; (3) recognize an individual who has excelled within an area of interest to the individual, not necessarily scholastic; and (4) to bring the public's attention an example of the constructive contribution being made by the youth.

TYPE OF AWARD AND RECOGNITION TO BE GRANTED

Regional Award winners are presented: A \$100.00 Series EE Savings Bond from the Association. Regional winners will be chosen from those applicants submitted to the Regional Director. The full Board will choose an annual winner from the Regional winners. The Youth will then receive at the Mid-Winter Conference: (1) a \$500.00 Series EE Savings Bond, (2) \$100 gift certificate, (3) an engraved wall plaque which indicates, in appropriate wording, the name of the Association as the donor, the name of the recipient, and the date of the presentation; and (4) an engraved wall plaque that is presented by the Association to the sponsoring court from which the recipient is nominated. Reasonable expenses for the recipient and his/her parents, guardian, or custodian for the day of the award ceremony at the Mid-Winter Conference will be paid by the Association.

NOMINATION PROCEDURE

The Association will furnish nomination forms to any member. These forms are to be used to identify deserving nominees and the court may use any selection process they desire.

The Court must be a current member of the Juvenile Justice Association of Michigan in order to submit a candidate. The Court may nominate more than one youth.

The youth nominated must be between 17 years of age and 21 years of age and discharged from the Court's jurisdiction.

Please remember, this award may well provide the funds
and recognition necessary for continued achievement by some
outstanding young person in your community.
