## Grant Opportunity

### *Status Offense Diversion Project*

Pursuant to Section 402 of the FY 2025 Judiciary Budget, the State Court Administrative Office (SCAO), in collaboration with the Michigan Department of Health and Human Services (MDHHS) and the Michigan Committee on Juvenile Justice (MCJJ), is pleased to present the **Status Offense Diversion Project** grant opportunity. Grant funding is available to juvenile courts for innovative, community-based diversion programs and services that work solely with youth for whom the court receives a complaint, referral, or petition for what is alleged to be a status offense.

SCAO seeks to award grant funding for up to five (5) courts in Michigan for the development of innovative pilot projects aimed at diverting status offenders towards community-based programs and services, and away from formal juvenile court involvement and secure placement.

### Enacted Legislation

#### [PA 0182 of 2024 - Modify Age Requirements for the Use of a Courtroom Support Dog](#)

Statute Cite: MCL 600.2163a

Effective Date: April 1, 2025

What it does: This act modifies the age of child witnesses who are allowed to be accompanied by a courtroom support dog when testifying as follows:

- 1) An individual under 16 years of age or 16 years of age or older with a developmental disability; or
- 2) An individual under 18 years of age or 18 years of age or older with a developmental disability.

# MJJAS/OYAS Detention Screening Tool

## Training and Certification for Court Staff/Court Designee

SCAO is offering statewide training on the MJJAS/OYAS-DET screening tool at no cost to the courts. Please ensure that court staff/court designees responsible for conducting detention screenings on youth complete the training prior to using the MJJAS/OYAS-DET screening tool.

The MJJAS/OYAS-DET screening tool is designed to assess youth to determine if they pose a risk to reoffend, and aids in the decision of initial placement and/or release from detention. The MJJAS/OYAS-DET tool end-user training and certification is appropriate for court staff and court designated individuals responsible for conducting detention screening for justice-involved youth, and there is no pre-requisite to participate in the training. The end user training includes didactic presentation and practice of concepts and skills. The training also includes an overview of supportive research in the field, specifically the Principles of Effective Intervention. Participants will then be introduced to the MJJAS/OYAS-DET screening tool, reviewing supporting material for the tool that will be used to effectively conduct an assessment interview, and then score individual risk. Finally, the training will conclude with a “next steps” conversation to address how to begin using what they have learned.

**Target Audience:** These trainings are limited to court staff or court designated individuals responsible for conducting the detention screening tool. Training is exclusively focused on learning how to administer the tool and obtain certification.

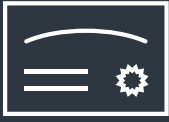

After registration, you will receive an e-mail to confirm your account and set a password on the State Court Administrative Office (SCAO) Learning Center, where the exam is hosted. Registration through the virtual link above and then confirming your account on the Learning Center is required.

## Juvenile Probation Officer/Caseworker Certification

Michigan Supreme Court Administrative Order 1985-5 requires a juvenile [court] probation officer/caseworker to complete the Michigan Judicial Institute (MJI) certification training within two years of employment.

The certification process is two-phased and can be completed in any order. Phase I requires participation in (or waiver of) the MJI “Basic Interviewing, Counseling, and Communication Techniques” webinar series. Waiver forms can be provided by request. Phase II consists of a self-paced study of the MJI *Juvenile Probation Officer and Caseworker Self-Instructional Manual* and satisfactory completion of the certification examination.

### **Manual:**

Study using the Self-Instructional Manual, revised in October 2024. The manual is available on our website [here](#).

### **Examination is Online:**

The exam is a computer-based application that you may take from the comfort of your home or office. However, you must still preregister to take the exam. Register for one of the following times:

**Thursday, January 30, 2025, 9:00am-12:00pm OR 1:00pm to 4:00pm**

### **Examination Details:**

- The examination is timed. You will have up to three hours to complete the exam. The examination is “open book,” so you may utilize your manual to assist you in answering questions.
- The format for the examination is primarily true-false, multiple-choice, and fill-in-the-blank.
- The examination is approximately 211 questions.
- There are no grades – it is pass-fail. You must achieve a score of 85 percent or better to pass the examination. This is based upon a cumulative score on the entire test.



## Juvenile Justice Vision 20/20 Webinar: Justice Reimagined: AI and AI Governance for Juvenile Courts

**Juvenile Justice Vision 20/20 is excited to announce** a groundbreaking presentation by Kevin J. Bowling JD on the development of Artificial Intelligence (AI) and AI technology applications within the juvenile justice system. He will also address the challenges that run parallel to the technology's implementation.

**As we strive to enhance the efficiency, fairness, and effectiveness** of our juvenile justice system in Michigan, and as a fairly new technology, AI stands as a beacon of innovation and potential worthy of great discussion.

### **Presenter: Kevin J. Bowling JD, MSJA, ICM Fellow**

Mr. Bowling has extensive knowledge of the courts and AI. He retired from the judicial branch of government following a 44-year career as an attorney, court administrator, judicial branch educator, and consultant. Mr. Bowling served as the Trial Court Administrator and Attorney Referee for the 20th Judicial Circuit Court and the Ottawa County Probate Court in Michigan. He also served for 20 years in a variety of positions with the Michigan Supreme Court, including State Judicial Educator and Regional Court Administrator. Additionally, he is a Past President of the National Association for Court Management (NACM); Co-Chair of the Joint Technology Committee (a collaboration of the Conference of State Court Administrators (COSCA), the National Center for State Courts (NCSC) and NACM; and Past Chair of the Department of Justice/Bureau of Justice Administration's Global Advisory Committee. His work in the judicial system includes judicial branch training in numerous US states and service in western Africa as Deputy Chief of Party for the Nigeria Justice Sector Assistance Project. As the current Chief Administrative Officer of the International Assoc. for Court Administration, he recently returned from presenting at their 20th Annual Conference in Singapore in which there were 53 countries present to learn about AI and its potential impact on the courts. Following the conference, he presented at the Singapore Supreme Court on AI and the Courts.

### **A Stakeholders Guide to Competency to Proceed in Michigan's Juvenile Courts**

The Michigan Department of Health and Human Services (MDHHS) is pleased to offer on-demand learning opportunities in reference to juvenile competency stakeholder information. Court personnel (including probation officers and managers, judges, referees, prosecutors, and attorneys), as well as advocates, behavioral health providers, MDHHS juvenile justice specialists and managers, and other MDHHS staff, are encouraged to complete the training. # MJJAS Full Suite of Tools

## Michigan Juvenile Justice Assessment System (MJJAS) FY25 Training

The Michigan Department of Health and Human Services (MDHHS) Division of Juvenile Justice (JJ) is pleased to announce the ninth year of Michigan Juvenile Justice Assessment System (MJJAS) risk assessment training on the full integrated suite of tools. The MJJAS is provided to MDHHS through a contractual agreement with the University of Cincinnati Research Institute and is also known as the Ohio Youth Assessment System® (OYAS). The MJJAS (aka: OYAS) is a structured risk assessment tool that identifies the likelihood of a youth engaging in future criminal behavior and informs appropriate risk classification. The MJJAS assessments can be re-administered over time to determine changes in risk level based upon changes in behavioral profile or life situation. The MJJAS can be used at five different decision points for a youth: diversion, detention, disposition, juvenile justice residential placement and reentry to the community from residential placement. In addition to risk assessment, results from the disposition, residential and reentry tools are assistive for case planning and for identification of residential and re-entry service needs.

### Juvenile Justice Case Management

The MJJAS is the designated risk assessment system for juvenile justice youth under the care and supervision of MDHHS. Service plans and residential treatment plans entered in the Michigan Statewide Child Welfare Information System (MiSACWIS) require administration of the MJJAS for juvenile justice youth.

### Recommended Recertification

MJJAS recertification training is recommended for MDHHS JJ specialists and supervisors, as well as public and private juvenile justice facility case workers and supervisors who write service plans or residential treatment plans for MDHHS juvenile justice youth who were certified three or more years ago to ensure fidelity to the tool. Participants must successfully complete this training to be certified to administer the MJJAS risk assessment instruments.

### Training Registration

There is no registration fee for this training. JJ specialists and supervisors, and public and private residential treatment staff and supervisors working with juvenile justice youth under the care and supervision of MDHHS will be given priority to register for this training. Registration for others is on a first-come, first-served basis. Participants who fail to attend, arrive late, depart early or attend only portions of the training will not be eligible to receive certification to administer the MJJAS. Virtual classes will close approximately two weeks prior to registration or sooner if class size is reached – maximum class size is limited to 15 participants.

Registration for MJJAS classes should be completed using the MDHHS Learning Management System (LMS) for all MDHHS staff and private contracted facilities. County Court and detention staff can inquire and register by contacting [MDHHS-MJJAS@michigan.gov](mailto:MDHHS-MJJAS@michigan.gov). MDHHS and private contracted facility staff with access to MiSACWIS should have MDHHS LMS access and should follow the listed steps in LMS to register for the training. If you encounter problems or need assistance registering for training, contact the LMS helpdesk at [MDHHStraining@michigan.gov](mailto:MDHHStraining@michigan.gov). If you need to cancel after you have been confirmed to attend the training, this should also be completed through the LMS.
